

# Important Information Regarding RI Family Court Child Support Hearings

Most child support matters have been scheduled via **WEBEX/telephonic hearing** by the Rhode Island Family Court. This includes all Family Court locations: Providence, Kent, Washington, and Newport Counties.

A constable will be serving you with a motion, summons and subpoena. Please note: The WebEx / Telephone number printed on the forms should be used to contact the Court on the date/time of your scheduled hearing. If you cannot locate that information, please refer to the table below. Here, each Court room has the appropriate telephone number/access code and WebEx URL listed with the Magistrate name / room number.

**If you are a T-Mobile subscriber, you should contact the Court using 1-617-315-0704 and access code listed for your scheduled hearing.**

Please note: The 1-408-418-9388 telephone number will continue to connect you to your scheduled hearing; however, T-Mobile customers may be charged a fee. **To avoid being charged a fee, litigants should contact the Court using 1-617-315-0704 and the appropriate access code. No fee will be accessed if you connect to your scheduled hearing using 1-617-315-0704.**

Please note there is a specific passcode and WebEx URL listed for each county and courtroom. **T-Mobile customers should dial in to the scheduled hearing using the 1-617-315-0704 telephone number/appropriate access code from the table below.**

Please confirm you are calling the correct phone number for the county and courtroom assigned to your hearing, at the specific time assigned. Do not call earlier or later than the time indicated as there are many other hearings scheduled. You may be placed on hold for a short time until the Magistrate or Judge calls your case and your name.

You will need to use the information listed on your subpoena / summons to participate in your scheduled court hearing on the date and time listed. If you have misplaced that information, use the contact information below to connect to the scheduled hearing.
