



The Court hereby enters this Administrative Order (2017-01) updating the Child Support Guidelines and Schedule and thereby amending the Schedule and Guidelines of Administrative Order 2012-03. This Administrative Order is hereby incorporated into Administrative Order 2012-05.

The amended schedule is attached hereto and becomes effective September 1, 2017. Please refer to the attached report and explanation regarding the new schedule, the amended Child Support Guideline Worksheet and revised Gross to Net Conversion Table.

ADMINISTRATIVE ORDER 2017-01
(AMENDING ADMINISTRATIVE ORDERS 2012-3)

In accordance with federal requirements, in January of 2017 the Rhode Island Family Court Chief Judge convened the Child Support Guideline Task Force to review the 2012 Child Support Guidelines. The task force consisted of the following members:

The Task Force completed its work in June 2017, submitting its final report along with a proposed 2017 Monthly Basic Child Support Obligations Schedule, and a proposed 2017 Gross to Net Conversion Table prepared by the Center for Policy Research. An amended guideline worksheet was also prepared. The next quadrennial review shall take place in January of 2021.

The Income Shares Model adopted previously by the Family Court remains the methodology upon which the schedule is based. The Betson-Rothbart measurement of raising children was also retained. The revised schedule incorporates economic changes which have occurred since the last review including federal tax rates, federal poverty guidelines, minimum wage increase, housing costs in RI and other economic factors. The guideline chart calculations take into account the 2017 federal tax rate, a 10% adjustment for RI Housing Cost at the low income levels up to \$6,050 per month, and a Self- Support Reserve equivalent to the 2017 fed poverty level for 1 person (\$1,005). The self- support reserve has been increased to correspond to the poverty levels since 2012. The inclusion of the self- support reserve insures that the obligor's have sufficient income to maintain a minimum standard of living.

Use of the 2017 Revised Schedule and Revised Worksheet

The instructions for the use of the Guideline Worksheet set forth in prior Administrative Order 87-2 should continue to be followed. All other Administrative orders not inconsistent with this Administrative Order shall remain in full force and effect. Prior Administrative Orders did not address consideration of Supplemental Social Security Benefits coupled with receipt of Social Security Disability Benefits; Imputed Income, or the amended calculation for child Care expenses. They are addressed in this Administrative Order.

Work Related Child Care Calculation

The Task Force suggested a modified approach for calculating issues relating to child care expenses proving an above the line adjustment for both the custodial parent and the non-custodial parent to reflect the amount actually available for calculating a child support order. The policy contained within 97-8 which provides that the custodial parent is entitled to claim the federal tax exemption for children will remain in full force and effect. The Guideline Worksheet has been amended to reflect the above the line deduction from gross income and is attached herewith

Examples of the new work related child care calculation are attached as guidance.

Supplemental Social Security Income (SSI) coupled with Social Security Disability Insurance (SSDI)

If the non- custodial parent receives combined SSDI and SSI the income shall be treated as SSI income and therefore cannot be considered as income for purposes of establishing, modifying or enforcing a child support order.

Imputed Income

If the Court, within its discretion, decides to *impute* income in a particular case, the Court shall take into consideration the specific circumstances of the noncustodial parent and the custodial parent)to the extent known, including such factors as the noncustodial parent's assets, residence, employment and earnings history, job skills, educational attainment, literacy, age, health, criminal record and other employment barriers, and record of seeking work, as well as the local job market, the availability of employers willing to hire the noncustodial parent, prevailing earnings level in the local community, and other relevant background factors in the case.

Incarceration-

Incarceration considered by *itself*, may not be treated as *voluntary unemployment* for purposes of preventing someone from filing a motion to modify a child support order or denying a motion to modify. However, circumstances surrounding the incarceration of the obligor may be

considered with all other factors and circumstances related to the incarcerated obligor's ability to pay support and any other equitable considerations relevant to the specific circumstances of the case.


Deviation from the Guideline Amount-

A written finding or specific finding on the record of a judicial or administrative proceeding for the award of child support that the application of the guidelines would be unjust or inappropriate in a particular case shall will be sufficient to rebut the presumption in that case, as determined under criteria established by the State. Such criteria must take into consideration the best interests of the child. Findings that rebut the child support guidelines or deviate from the guideline amount shall state the amount of support that would have been required under the guidelines and include a justification of why the order deviates from the guidelines.

In all respects not inconsistent herewith, the procedures set forth in Administrative Orders 1987-2, 1997-8, 2002-03, 2012-3 should be followed.
